



# NEW COVID-19 REQUIREMENTS FOR HAULIERS TRAVELLING TO ENGLAND FROM ABROAD FROM APRIL 6 2021

ALL HAULIERS STAYING IN ENGLAND FOR LONGER THAN 2 DAYS WILL BE REQUIRED TO TAKE A COVID-19 TEST WITHIN 2 DAYS OF ARRIVAL:

- You will need to take a test if you are staying in England for longer than 2 days
- You will need to take a test within 2 days of your arrival
- You will then need to take a further test every three days
- You do not need to take a test if staying in England for less than 2 days
- This **does not** apply to Hauliers arriving from Ireland.

ALL HAULIERS MUST ALSO SELF-ISOLATE IN YOUR CAB WHILE YOU ARE IN ENGLAND. YOU WILL ONLY BE ABLE TO LEAVE YOUR CAB:

- To buy food, and to take a Covid-19 test
- Use a toilet or undertake limited exercise
- To refuel, and to ensure the load and vehicle are road worthy
- Or to sleep if the cab has no overnight compartment.

YOU MUST COMPLY WITH BOTH TESTING AND SELF-ISOLATION RULES IF YOU'RE A HEAVY GOODS VEHICLE (HGV) DRIVER, HGV CREW, OR A VAN OR OTHER LIGHT GOODS VEHICLE (LGV) DRIVER.

**IF YOU DO NOT COMPLY WITH THESE NEW LEGAL REQUIREMENTS YOU WILL BE SUBJECT TO A FINE, UP TO £2,000.**
