

GENERAL CONDITIONS OF THE COMPETITION

This competition is organised by the company FRANCE MANCHE, registered with the Companies' Register of Paris under number B 333 286 714 and having its registered office at 3 rue de la Boétie, Paris (75008).

You must accept these terms and conditions to take part in the competition.

A. CONDITIONS FOR TAKING PART

- i. To take part in the competition, you must meet all of the following conditions:
 - you must be a Eurotunnel Le Shuttle Freight customer,
 - you must be a lorry driver,
 - you must be at least 18 years old,
 - you must have a valid ticket to travel during the competition period.

Each participant may only play individually in his or her own name.

- ii. The competition will begin on 21 June 2021 at 12:01 am and end on 31 August 2021 at 11:59 pm.
- **iii.** A ticket to travel through the Channel Tunnel will give you the right to play once, with a maximum of one entry per day.

If two drivers are present in a vehicle, each driver may play individually.
