



Advisory Notice

To: All traders importing consignments through a BCP in N. Ireland destined for Ireland which require official controls at a BCP

We have been advised that there will be disruption at Border Control Posts (Points of Entry) in Northern Ireland due to a planned 5-day industrial action, week commencing 30th October. We understand that this disruption will likely affect the performance of official controls on consignments coming from GB that are destined for Ireland.

We would advise any traders who import consignments destined for Ireland through a BCP in Northern Ireland to keep in close contact with the NI authorities and consider alternative options of entry during this planned period of disruption.
